

#### ***Province Launches Review of the Ontario Municipal Board (OMB)***

The Ministry of Municipal Affairs and the Ministry of the Attorney General are working to develop proposed recommendations to improve how the Ontario Municipal Board (OMB) works within the broader system of land use planning. A consultation paper will be released in the fall 2016 for further comment. In the meantime, the province is seeking input on the following topics:

- Meaningful citizen participation and local perspective
- Clear/predictable decision making
- Hearing procedures and practices
- Alternative dispute resolution
- Timely processes and decision making

### Six-Story Wood Frames in Ontario


New Ontario Building Code amendments to permit six-story wood-frame construction were enacted in early 2015, creating buzz amongst developers trying to gain competitive advantage, as well as planners looking to introduce a mid-rise and mixed-use development format into challenged urban environments. The amendments increase the permitted height for multi-residential, commercial office and other mixed-use format developments from the previous four-story cap.

## Advance Notice of a Motion for the Annual General Meeting (AGM)

Come and join your fellow planners at the Annual General Meeting (AGM). This is your opportunity to find out about *Inspire OPPI* and the Institute's new Strategic Plan. Come and learn about how OPPI is supporting and promoting planners and planning in Ontario. These are exciting times for the profession. Make plans to attend! The AGM is on Wednesday, October 5th from 5:30 pm to 6:15 pm at the Convention Centre in Hamilton. This is taking place during the first day of the 2016 Symposium: *Healthy Communities & Planning for the Public Realm*. You do not need to register for the Symposium to attend the AGM.

We are currently in the process of drafting the agenda for the AGM. OPPI supports a fair process whereby members are given advance notice of proposed motions to be made by members attending the AGM. In this way as many members as possible have the opportunity to consider motions, decide whether to attend the AGM in person or to complete a form of proxy so their vote can be counted. To ensure adequate notice, any motion to be made at the AGM must be provided in writing and signed by three (3) members of OPPI eligible to vote on or before 5:00 pm on July 15th. Motions must be of a substantive matter and can be submitted by completing this [on-line form](#).
