In completing a thorough review and analysis of the demographics, we were able to identify immediate and future needs for CS&F. Results of the demographic analysis demonstrated that the diversity of the population in the Study Area has led to an abundance of ethnically-specific and culturally-based social programs which strengthen the social fabric and encourage inclusivity within the community.

#### Plan and Policy Making (Planning Approaches)

This project informed a larger project being initiated by the City of Built Form Study. This CS&F was one planning instrument used in a larger scale planning effort.

#### Plan and Policy Making (Strategic Information Gathering and Analysis)

I was responsible for consulting with the service providers and obtaining the relevant information which was required in order to successfully complete the project. In understanding what key information was needed (i.e. usage rates, occupancy/vacancy/capacity values, programs offered, sources of funding, etc.) it helped me create a set of questions to guide these phone-interviews and gather the information in a timely, and organized manner.

#### Critical Thinking (Problem Solving and Decision Making)

Part of the project was the creation of recommendations to provide to the City which suggested methods of increasing funding sources for the CS&F. In doing so, we realized the high price of land values and the relatively low density at which current facilities are constructed. One of the problems identified was the future lack of CS&F that the City would face given future projection demands for the Study Area. To counter this, we recommended selling off specific City-owned properties (located within the Study Area),

on the condition that a community facility be constructed as part of the future development. The excess of funds from the land sales could also be used to improve existing community facilities and programs.

## Critical Thinking (Research and Analytical)

My research and analytical skills were used throughout this project. In order to conduct a thorough analysis of the area's demographic composition, I had to compare all data available and relate it to the CS&F offered (i.e. growing population → what services would be anticipated; aging population → more senior services; etc.). I was able to proficiently analyze, compare and present my research in a manner which contributed to the completion of the project. We found that there was a shortage of child-care spaces, which would be exacerbated by an increasing population as well as an increase in employment space. There was also a shortage of programs geared towards young adults. With the built form in the area being predominately 1 and 2 bedroom condominiums and a younger demographic, it was determined that the City should place some funding in programs geared towards this age group. This project enabled me to research, compare, analyze and evaluate data, affording me the opportunity to improve my research and analytical skills.

In speaking with numerous service providers in a relatively small pocket of the City and hearing and researching how many different community services are ethnically or culturally specific, it helped me realize how truly diverse this City is. #### **Specific Competency:**

#### **Policies & Application**

As part of this project, we undertook an extensive evaluation of the area's existing policy framework and the current tools/strategies which the City is using to implement its policy. This policy review led to an indepth analysis of other methods and tools which could have been used to guide future development and planning in the Study Area. These included looking into the feasibility of adopting a secondary plan, site and area specific policy, interim control zoning by-law, etc.

#### Plan and Policy Considerations (Functional Integration of Knowledge)

I gathered all relevant background information for the lands, including details on the policy framework (local and provincial policies), demographic statistics, community services and facilities and available planning tools. All this knowledge was strategic in making an informed and professional policy recommendation which best suited the area.

#### **Finance and Economics**

By attending both stakeholder and working group meetings which allowed for landowners and the public to speak freely, the differences of perspectives between the private and public sector was quite evident. Both parties were in support of the project, and an enhanced policy framework for the area, but their ideals and goals of this enhanced framework differed. Examples include landowners seeking less-strict rental housing provisions and increased height/density parameters whereas residents preferred to have the area redeveloped at the same height and density scale that exists there today.

# Plan and Policy Making (Strategic Information Gathering and Analysis)

Throughout the project, evaluations took place comparing the existing policy framework (Official Plan) to other tools/strategies (localized policy) which could potentially be implemented. Taking all this background research and putting forth a well-researched and supported recommendation for the City to implement was based off knowledge gained from thorough analyses of different policy tools.

#### Critical Thinking (Issues Identification)

Building upon the feedback gathered throughout the public consultation process, I was able to further identify issues once I completed certain aspects of the project (i.e. demographic analysis, community services and facilities review). Also, it enabled me to simplify and categorize issues into a format which provided input to the final report.

As well, throughout the process, members of the public had difficulties comprehending the difference between a Provincially designated 'Urban Growth Centre' and the City of land use designation which encouraged growth (the 'mixed use' designation in the City Official Plan). This issue was then identified and thoroughly explained through PowerPoint presentations, policy explanations and case study examples.

## Interpersonal Skills (Facilitation, Integrity & Trust, Collaboration and Consensus Building)

During public consultations, I gained skills and an understanding in facilitating public meetings of large groups of people and reading the audience. The purpose of these meetings was to collaborate with public and reach a common goal. I also learnt that a key component of facilitating meetings of this style is to earn the trust of the group before you, by providing honest and objective opinions/views to the public.

# **Communication (Listening)**

During the public consultation phases, I gained listening skills and learnt how to decipher and categorize comments into a workable format that provided valuable input to the final analysis and recommendations. I was also responsible for recording questions, comments, and creating minutes which were made public by the City of

Throughout the public consultation process there were instances of mistrust and false allegations about the project scope; truncated project timeline and municipal budget constraints. There were also moments of aggressive behaviour displayed by some members of the public. In an effort to curb this, all explanations and answers provided by myself and the rest of the team were given in a professional and honest manner. I realized early on in the process the importance of building a relationship based on honesty and trust with the public and the working group members, which played a large role in successfully coming to a project conclusion.

Project Description:
This project was an update to a Highest and Best Use Study that 2008. Due to recent changes in municipal policy, land values and a large-scale downtown revitalization taking place in the City, the landowner requested that the previous study be updated. The property is located at Street in downtown with the City's provincially designated Urban Growth Centre. The project included a review of the provincial and municipal policy and regulatory framework, the area's demographics and an update on surrounding land use and development activity. It also provided recommendations on the site's highest and best use and presented an estimated land value based on historic surrounding land sales, property tax assessments and current property listings.
Project Role:
For this project I was responsible for undertaking a review of the provincial and municipal policy and regulatory framework for the site. Provincial documents included the Provincial Policy Statement and Growth Plan whereas municipal documents included the Official Plan, Downtown Community Improvement Plan, Downtown Master Plan, Intensification and Implementation Plan and the City's Zoning By-law. As well, I conducted a demographic review of the downtown area of comparison to the larger City using data from Statistics Canada at the census tract level. This review included information on population and age, visible minority, aboriginal population, education levels and household income. The demographic analysis also consisted of an extensive review of existing versus projected student population numbers, considering that post-secondary institutions play a significant role in downtown. I collected information on recent development activity within the downtown core, determining the amount of recent and ongoing residential/non-residential square footage through development permit information and speaking with municipal staff. As well, in order to complete the land value assessment, I reviewed recent land transactions and current property listings using a variety of

online tools, sources and speaking with local real estate representatives. All of the information I gathered was summarized into report-format to be included in the final submission to the client.

#### **Human Settlement (Influences on Communities)**

In this instance, this influence from the Province may play a role in shaping and guiding the physical design of this site and ultimately downtown

Through the provincial and municipal policy review that was undertaken for this project, I learnt the array of tools and strategies that the City of has employed to guide the revitalization and future development of its downtown core. It is evident that these different tools and strategies were used for their specific planning contexts (i.e. the use of a Community Improvement Plan to stimulate development by offering financial incentives). Also, when summarizing the policy and regulatory framework for this project, myself and other members of the project team advised on the policies stating how they may affect the site's redevelopment.

## **Finance and Economics**

By completing this project for a private landowner, it was easy to see his interests versus the interests of the municipality. He was looking to maximize the development potential of his property whereas the City was looking to abide by the site's provisions and maximize community benefit. Our role, as planners was to set aside all differences and determine the site's highest and best use by being subjective and taking into account all necessary policies and provisions.

#### Plan and Policy Making (Strategic Information Gathering and Analysis)

My involvement in this assignment was based on my ability to gather and analyze information. Through past project experiences, I have been able to gather and effectively disseminate information that has been needed, and this project further improved these skills. I used several forms of media to gather the information required which was then analyzed using Excel and other computer programs and finally summarized into written format. All of the information presented in the final submissions was used to inform and support our recommendation of the site's highest and best use.

## **Developments in Planning (Emerging Trends and Issues)**

This project was an update to a study completed in 2008. The entire premise of the project was to update the previous study based on new trends and issues that were raised due to changes/updates to provincial and municipal policies and plans. In an effort to monitor this, a significant portion of the project consisted of a policy review. Also, due to the recent changes in policy providing for more development flexibility, it was assumed that the property value assessment may have changed. This led to the updated land value assessment based on surrounding recent land transactions, property tax assessments and current property listings. In providing recommendations on the highest and best use of the property, we were assessing the site's potential to apply to provincial and local plan's as well as stating any innovations and improvements that could be made to the policy in order for the site to developed in a manner which adds the most community value.

## Critical Thinking (Research and Analytical)

I used different methods (i.e. – internet search, contacting staff and real estate professionals, review of hardcopy information) to find all the relevant information needed in order to conduct a proper analysis on the policy framework, demographics and land value assessment. When information was provided from multiple sources, it was compared for accuracy and all cause/effect relationships were identified; prior to being disseminated and summarized for the final document.

# Communications (Written and Oral Presentation, Information and Knowledge and Use of Information Technology)

For this project, I communicated with a number of municipal staff members as well as local real estate representatives expressing my thoughts and ideas in a verbal manner which were clear, effective and organized. This helped me gather the relevant information in a timely manner. As well, all of the information and data collected via phone, online or other sources of media were disseminated and summarized into a report- format for final submission.
