OPPI OUTREACH TO ONTARIO MPPs



On June 29, <u>Ontario's new government was sworn in</u>. Many returning Progressive Conservative MPPs received significant Cabinet positions in key areas that relate to the planning profession, and that OPPI has met with previously to get the Registered Professional Planners Act passed in the last session of the Legislature.

OPPI has started reaching out to key members of government, including party leaders, Cabinet ministers and party critics.

Through these introductions, OPPI is stressing the importance of RPPs and the planning profession to the Ontario government and individual ministries, finding common ground where OPPI can assist and build capacity.

Outreach will continue with the government and MPPs, including meeting with new and returning members to ensure continued support for the planning profession.

OPPI BY-LAW UPDATE

As we mentioned in previous newsletters, OPPI is embarking on an update of its by-law.



OPPI is seeking an update to its by-law, specifically to update its complaints and discipline process. An updated process allows OPPI to set a framework that enhances and improves the effectiveness of the current practice.

Leading up to the voting period, OPPI will provide more information to members on the voting process, proposed by-law updates and a Frequently Asked Questions document through targeted eblasts. Please keep an eye out for this communication from OPPI. We will also inform members when they can expect to receive their electronic ballot to vote on the proposed change. Stay tuned for more information.

BUILDING RPP

CPL REMINDER TO TRACK 2018 UNITS



As we all enjoy the summer months, we are more than halfway through the year and this is a good time to start logging your <u>Continuous Professional Learning (CPL)</u> units accumulated to date.

For 2017, over 98% of members met the CPL requirement, and this is great news! To date, 14 percent of members have already met their CPL requirements! We are well on our way to matching, or exceeding, last year's result.

Before the fall approaches, and everyone returns from summer vacation, take a few moments to log your CPL units in the Member Portal and avoid the rush at the end of the year to log all your units.

As a reminder, 18 learning units are required annually. One learning unit equals one hour of direct planningrelated (with some exceptions). A minimum of nine learning units must be structured and a maximum of nine learning units may be individually directed. And, up to nine structured learning units may be carried forward to the following year.

FOURTH ANNUAL LAKELAND DISTRICT JANE'S WALK

In June, OPPI's Lakeland District held their fourth annual Jane's Walk in the City of Barrie, led by:

The walk began at Barrie's waterfront and focused on the themes of public realm, walkability, connectivity, mix-use, the environment and quality of life.

Attendees strolled through the new Military Heritage Park to observe some of the horticultural and design components of this landscaped memorial space. The walk continued through the wildflower meadow and trails to see first-hand the importance of such areas within a City, and to identify some of its features,

such as the numerous native red oaks of varying sizes, which can live between 200 to 400 years.

The walk continued through the community of Minet's Point examining some of the area's successes, such as the residential densities, environmental buffering, and varied design. In contrast, the group observed the challenges within the community, such as street design, planning for flood prone areas and lack of mixed use opportunities within a walkable distance.

While enjoying the walk, the final stop was at a local ice cream shop, in business since the 1960s, allowing organizers to talk with attendees and link the idea of the public realm with building social capital in neighbourhoods. Relationships between neighbours can provide the foundation for mutual trust, shared efforts and resilience.
