

OPPI Opportunity Scholarship Evaluation Rubric

This assessment rubric supports a clear, fair, and accessible review of applications for the OPPI Opportunity Scholarship. The scholarship recognizes undergraduate and graduate planning students who face systemic barriers to education and who are actively contributing to their communities.

This rubric is grounded in OPPI's Statement of Action on Diversity, Equity, Inclusion, Reconciliation, and Social Justice (DEI-RSJ). It reflects OPPI's commitment to creating diverse and accessible pathways into the planning profession, supporting future planners, and fostering respectful, reciprocal relationships with communities impacted by planning.

Assessors are expected to apply this rubric with care, cultural humility, and an understanding of varied lived experiences.

Eligibility Criteria

- Must be a student member of OPPI
- Must be enrolled in a full-time, undergraduate or graduate planning program for the upcoming academic year
- Must self-identify as Indigenous (First Nations, Inuit, or Métis) and/or as a member of one or more equity-deserving groups
